CHIEF'S REPORT on Operations, Training.

- April calls: 280 total calls in the District, E349 188, R-1 T-1, M49 253
- We will be participating in an Evacuation Drill in Log Town this Saturday from 9:00 to noon. Thirty homes will be participating and the El Dorado County Sheriff's Office will use the alert system to evacuate them. They will be evacuated to UMHS and there will be a Town Hall Meeting after to discuss how it went. The Diamond Springs FSC will also be having a Fire Safe Event that same day between 12 and 4 at the Fruit Growers Association.
- Update on Mica Chief Gallaher drove by, and the area surrounded by the gate is overgrown with weeds. The community is supposed to keep it clean. There is a Knox Box on the gate. If they are going to use this as a secondary egress it will have to be cleared.
- Finished RT 130 training and are doing Swift Water Training this month.

OLD BUSINESS

DSP-ECF Working Group – Gallagher/Rutherford – Met on May 1st – Feasibility Study approved. Working on communications and figuring out what to do with the web pages. The CalPERS Legislation is still in process. Bill Passed Senate, issue with name being corrected and will be sent back through. CalPERS healthcare meeting with Chief, Admin. Info to Attorney to revise the resolution for healthcare. Met with N. Tahoe about their process. Retirement and benefits not the same for their annexation because Meeks Bay doesn't have any employees. N. Tahoe is providing their staffing. They have completed the AB8 negotiations with El Dorado County and will be starting the negotiations with Placer County. The Chiefs

had a meeting with LAFCO, the consultant and the surveyor's office for the mapping project. SOG/Policy Meeting is scheduled for May 31st at 9 at St 49.

The Directors discussed how to structure the Board for the Annexation and it is a consensus that we bring 2 Diamond Directors over to form a Board of 7 which will later be brought back down to a 5-person board.
